Eligibility:

- (i) AMaster's Degree with minimum 55% marks in Management / Information Technology / Cooperation & Banking
- (ii) Ph.D./NET/SLET/SETintheconcerned/allied/relevantdiscipline
- (iii) Aminimumoftwoyearsofteaching/trainingexperience

Candidates with higher years of professional experience in the relevant field may be given preference.

Tenure of Contract: The candidate will be initially appointed for a period of 3 years. However, their performance will be assessed on yearly basis. If their performance is satisfactory they will be continued for the agreedtenure. The tenure of contract may be extended for further period of two years on satisfactory performance. No further extension of tenure beyond five years is permissible.

Annual Incentive: The person will be given 5% annual increment on the consolidated remuneration as an incentive amount if his/her performance is found satisfactory. However, every year extension of services on the basisof performancewith5% incrementshallbedoneatthelevelofSecretary,NCCT.Annualincrementbeyond 5% to 15% maybeconsidered on extraordinaryperformance of thelecturer and Institute may recommend his/her case with justifiable reasons supported with documentary evidence to NCCT HQ for consideration of Competent Authority.

Monthlyremuneration:

- (a) RangeofConsolidated Remuneration for the post of lecturer is between Rs. 40000-90000.
- (b) There willbenoother allowance(s)inaddition to theaforesaid monthlyconsolidatedremuneration.
- (c) The consolidated remuneration may be fixed between the range as mentioned above on the basis of candidate capabilities and merits of the case and last pay drawn.
- (d) Theremuneration of selected candidates hall be fixed within the given range, according to the qualification and experience of the candidates ubject to the condition that it shall not be in excess of 10% of last paydrawn by the candidates in previous employment.

TERMSANDCONDITIONSFORAPPOINTMENTOFLECTURER(ONCONTRACTBASIS):

- 1. Incasetheperformanceoftheperson soappointedisfoundunsatisfactory, his/herserviceswill beterminated any time after giving one month's notice without giving any reason thereof or pay in lieu thereof. In case of resignation from thepost, onemonth's notice or payin lieu of noticeperiod shall be deposited.
- 2. Leaveofabsence:Thepersonappointedoncontractbasiswillbeeligiblefor15daysleaveinaCalendarYear. Itcannotbecarryforwardedtonextcalendaryear.Anyotherleaveforanypurposewillbeconsideredasleave without pay.
- 3. Persons so appointed on contract basis will not be eligible for any allowance except consolidated monthly remuneration. Hewill not claimany terminal benefit on termination of his contractual appointment.
- $4.\ The person appointed will come under the ambit of conduct rules as applicable in NCCT.$
- 5. The personso appointed will require to attend respective of ficed uring working hours' and days in week. He/she will have to attend the officed uring holidays in case of exigency of work.
- 6. The person appointed will require to maintain confidentiality of the work assigned to him/her by the Institute.
- 7. The personselected for appointment will require to show his all original certificates required for verification for eligibility for the post.
- 8. In case of outstation program the person so engaged will be provided boarding and lodging or TA/DA as per rules prevalent in NCCT, as per the entitlement of the post.
- 9. The mere possession of the prescribed essential qualification and experience does not entitle candidates to be called for the interview. Only short listed candidates as per criteria decided by the ICM will be invited for interview.
- 10. The dates of interview will be communicated through email (as provided in the application form) to the shortlistedcandidates. Anychange or correspondence address/email/phone from the one given in the application form should at once be communicated to ICM.
- $11. \ Candidates are advised to visit the ICM website at regular intervals for the updates.$
- 12. The ICM shall process the applications entirely on the basis of information/documents submitted by the candidates. In case the information/documents are found to be false/incorrect by way of omission or commission, the responsibility and liability shall lie solely with the candidate.
- 13. All appointments shall be made provisionally subject to verification of documents. The ICM shall verify the documents and antecedents of theapplicant at the time of interview/joining. In case, it is found any point of time that any document/information submitted by the applicant is false or the applicant has suppressed/concerned any relevant information, the services of the selected applicant shall be terminated forthwith without assigning any reason.
- 14. The ICM reserves the right to revise/reschedule/cancel/suspend/withdraw the recruitment process in part or full without assigning any reason. The ICM reserves the right not to fill up the vacancy as advertised. The decision of ICM shall be final and no appeal in this regard shall be entertained.
- 15. The offer of appointment to the selected candidates will be subject to verification of certificates/testimonials at the time of joining and completion of other formalities.
